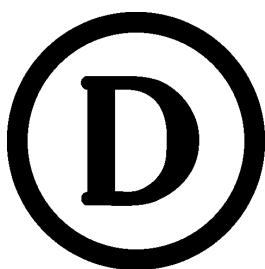

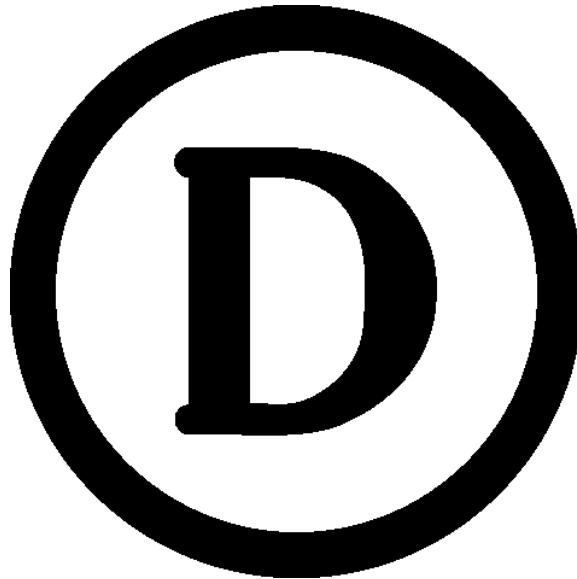

**Certification Mark D-Mark**
